Crop Choice EDTA Fe-4.5 is a fully chelated form of iron that is stable in 100% orthophosphate fertilizers. The addition of up to 5% by volume generally will not degrade the crystallization or long-term stability of the fertilizer.

DIRECTIONS FOR USE

The preferred use of Crop Choice EDTA Fe-4.5 is soil application to prevent iron deficiency. This micronutrient may also be used as a foliar spray.

Soil Application: Apply 1–2 quarts per acre in-furrow, 2x2, or as a side-dress or top-dress. Use caution when applying on seed in alkaline, saline, or coarse-textured soils.

Foliar Application: Apply 1–3 pints per acre. Use only as a supplement to a regular nutrient management program. Repeat applications may be beneficial. Use only as directed to avoid foliar burn. Do not apply in excessively dry or hot conditions. Using a surfactant may enhance leaf coverage and increase nutrient absorption.

MIXING DIRECTIONS

Fill spray tank with water before adding fertilizer or Crop Choice EDTA Fe-4.5. Agitate to ensure proper mixing. Always conduct a jar test with new combinations.
